SPECIAL CONSIDERATIONS:

This position is subject to random drug testing and a background check as a condition of employment. This individual operates Tribal vehicles and equipment on a regular basis. This person comes into close contact with children and seniors in the course of delivering services to the community. This individual works in hazardous environments (machinery, electricity, chemicals).

JOB SUMMARY:

Under the direct supervision of the Senior Citizen Program Coordinator, the incumbent will be responsible for preparing food, following menus accurately and for the proper cleaning/sanitation of soiled dishes, pots and pans. Will also be responsible for serving the elders lunch, breakfast and prepare meals for the homebound clients. In the absence of the cook will prepare and cook meals. At times, be required to drive van to deliver meals to homebound elders.

DUTIES AND RESPONSIBILITIES:

1. Prepares salads and desserts in accordance to meal menus.
2. Assists with creating monthly calendar/menus.
3. Participates in meeting functions.
4. Complies with established Quality Improvement standards.
5. Complies with established Infection Control standards.
6. Complies with established safety functions and requirements.
7. Helps restock and maintain inventory levels to insure proper supplies for department function.
8. Cleans own work areas, equipment used, walls, cabinets, storage areas, and other areas assigned in accordance with established procedures.
9. Washes cookware using approved procedures.
10. Will shop for and help unload groceries, storing them in appropriate locations.
11. Answers the telephone.
12. Accepts and performs other duties as directed by the immediate supervisor.
13. Assist with end of the weeks clean-up.
